REPORT FROM HARBORMASTER

Harbormaster Tim Frame reported on the following:

- All electric is on at the 700 and 800 docks. Not operating to design speck, we will deal with that in the fall.
 Everything is usable as of last Friday.
- Stone Barges on the City Wall is a Corps of Engineers project. The stone is to add reinforcement to the detached

break water.

- They are placing 10 thousand tons of stone, 6 or 7 more barge loads coming. Each barge load holds 9 Hundred tons.
- Expect to be done by July 4th.
- Trail Creek continues to launch boats, had some people waiting for the power to go on to launch.
- o Credit cards were not working last Friday at the gas dock, we had to clear the buffer and they were up and running within a couple of hours.
- Washington Park launch ramp has too much sand in the launch area and we need to get a dredge permit to dig the sand out of the ramp area. One and half lanes blocked off on North side, south lane is usable.
